IV TAYPLAN PROGRESS REPORT

There was submitted Report No SDPA01-2016 by the Acting Strategic Development Planning Authority Manager updating the Joint Committee on the progress of TAYplan's work, TAYplan's achievement in winning an award for the proposed TAYplan Strategic Development Plan in the Scottish Awards for Quality in Planning 2015, the Minister's feedback on the Planning Performance Report 2014/2015, and TAYplan's submission to the Scottish Government's review of the Scottish Planning system.
