II MINUTE OF MEETING OF 23RD NOVEMBER, 2010

The minute of the above meeting was submitted and approved.

III PROPOSED STRATEGIC DEVELOPMENT PLAN 2012-2032

There was submitted Report No SDPA01-2011 by the Strategic Development Planning Manager seeking approval for the Proposed Strategic Development Plan and the Equalities and Human Rights Impact Assessment, and advising the Joint Committee of the Habitats Regulations Appraisal, the Schedule of TAYplan's responses to representations made at the Main Issues Report stage and the background Topic Papers.

The Joint Committee agreed to:-

- (a) approve the Proposed Strategic Development Plan and the Equalities and Human Rights Impact Assessment appended to the report, subject to the undernoted amendments to the Plan:-
 - Policy 3 Employment Land second bullet point amended to read "safeguarding areas identified for class 4 office type uses in principal settlements; and,";
 - (ii) Policy 3 Natural and Historic Assets second bullet point, last two lines amended to read "monuments and allow development where it does not adversely impact upon or preferably enhances these assets; and".
 - (iii) Policy 4 Strategic Development Areas Table 1 amended at West/North West Perth to read "4,000+ homes", at Oudenarde to read "1,200+ homes", and at Dundee Western Gateway to read "750+ homes".

- (iv) Policy 5 A- Housing Amendment of second sentence to read "Land should be allocated within each Housing Market Area (Proposal 2) through Local Development Plans to provide an effective and generous supply of land to assist in the delivery of in the order of 26,000 units up to year 2024"; and
- (v) Policy 5A Housing Amendment of fourth sentence to read "in the period 2024 to 2032 in the order of 17,500 units may be required."
- (b) adopt the Habitats Regulations Appraisal, the Schedule of TAYplan's responses to representations received at the Main Issues Report stage, and Background Topic Papers, published with the Report;
- (c) request that the four constituent Councils ratify the decisions at (a) and (b) above, and, including the Cairngorms National Park Authority, approve the Habitats Regulations Appraisal;
- (d) delegate the Strategic Development Planning Authority Manager to undertake the Proposed Strategic Development Plan period of representations in line with the statutory requirements and the Participation Statement as set out in the Revised Development Plan Scheme appended to Report No SDP03-2011.
- (e) delegate the Strategic Development Planning Authority Manager to report back to the Joint Committee in October 2011 on the representations received to the Proposed Plan; and
- (f) delegate the Strategic Development Planning Authority Manager to make minor technical and presentational amendments in respect of (a) and (b) above, arising from the changes agreed by the Joint Committee at this meeting.

The Joint Committee also expressed their appreciation to Perth and Kinross Council for the work carried out in the Strategic Environmental Assessment

- (d) delegate the Strategic Development Planning Authority Manager to report back to the Joint Committee in October 2011 on the representations received to the Proposed Action Programme; and
- (e) delegate the Strategic Development Planning Authority Manager to make consequential amendments arising from changes agreed by the Joint Committee at this meeting in respect of the Proposed Strategic Development Plan.
